

What is Wisconsin Works

Wisconsin Works (W2) assists individuals in meeting their employment & career goals.



Individualized services are provided to each participant through W2 agency staff, partner agencies, and Wisconsin Job Centers.



The goal of Wisconsin Works (W2) is to provide necessary and appropriate services to prepare individuals to work, and to obtain and maintain viable, self-sustaining employment, which will promote economic growth. W2 is designed to ensure that everyone in Wisconsin shares in our economic opportunities.

W2 Payments Totaled \$25,144,701 These payments served 10,341 individuals and their families





Who Is Eligible?

Available to ALL parents (both custodial and non-custodial) with minor children, low assets, and low income who meet the financial and non-financial criteria.


There are different levels of placement within W-2.

Each level of placement is tied to a participant's current ability for work and retraining a job.

Based on an individual's situation, skills, resources, barriers to employment, and eligibility, he/she will be offered a specific placement in W-2.

Supportive Services Available

Child Care: Families may apply for help with establishing and paying for childcare. Transportation: W2 participants may receive help in finding and paying for transportation to and from work.

Examples of Career pathways to W2 participants



Emergency Assistance

Provides assistance to eligible families who are experiencing an emergency due to fire, flood, or natural disaster, impending homelessness, homelessness, or energy crisis.



Eligibility Criteria

Non-Financial Eligibility

- Caretaker relative of at least one dependent child
- All group members are US Citizens or qualified non-citizens
- Reside and intend to reside in WI
- Qualifying emergency
- Not received Emergency Assistance in past 12 months
- Financial Crisis beyond your control (except in cases of DV and homelessness)

Financial Eligibility

- Based on gross income
- Cannot exceed 115% of the Federal Poverty Level (currently set at \$2383 per month for a family of 4)
- Countable assets of \$2500 or less



Job Access Loans

Job Access Loans are short-term, no interest loans up to \$1600 designed to assist eligible individuals to meet emergency needs that support employment. Some acceptable uses include but are not limited to: fees for obtaining a driver's license, car repairs, down payments, uniform supplies, and equipment for remote work.



The applicant must have either a job or a bona fide job offer and meet all other financial and non-financial eligibility criteria to be eligible for a loan. Job Access Loan monthly repayments can be made in two ways: in cash or through a combination of cash and volunteer community service.



W2 Education Navigators

- The W2 Education Navigator is in regular contact with the educational systems in their regions and coordinates direct services for Adults and Youth seeking support and assistance in successfully navigating the completion or obtaining of their High School Diploma (HSD) or Equivalency degree while working with programs.
- Navigators may also assist in identifying and connecting with community resources to improve education levels and improve basic life skills while assisting with navigating barriers.



W2 Child Support Liaison (CSL)

The W2 Child Support Liaison is the primary contact between the W2 Agency and the Child Support Agencies (CSA) within the W2 geographical area. The CSL works directly with the CSAs in identifying and connecting noncustodial parents with limited earnings or ability to pay child support to employment services, including but not limited to Wisconsin Works (W2), Transitional Jobs (TJ), and the Trial Employment Match Program (TEMP), FoodShare Employment and Training (FSET), Vocational Rehabilitation, Veterans Employment Programs, Workforce Innovation and Opportunity Act (WIOA), as well as other services that may benefit the noncustodial parent.
