What is WIOA?

- Signed into federal law in 2014
- Designed to help job seekers access employment, education, training, and support services to succeed in the labor market and to match employers with the skilled workers they need to compete in the global economy



What is WIOA?

 Requires states to strategically align their core workforce development programs to coordinate the needs of both job seekers and employers



What is WIOA?


Built on three key pillars:

- 1. One-stop job centers provide first-rate customer service to job seekers, workers, and businesses;
- 2. The demands of businesses and workers drive workforce solutions;
- 3. The workforce system supports strong regional economies.


WIOA State Level Activities

- Organization of cross agency work groups




Wisconsin's WIOA Partnerships



Wisconsin state agencies align to administer WIOA programs.



What is a Referral?

- Providing information to a client, in a usable and understandable format, about another WIOA program, that you believe is appropriate to support that client with employment, training, and/or supportive services.
- By giving a referral to another program, it is believed that the other program could provide services to the client.
- Referrals can come in many forms and can include something as basic as providing access to information about another program, or as involved as actively connecting clients to other program staff.



Importance of Referrals

- Provide seamless, customer-focused, integrated service delivery across all WIOA title and partner programs and enhance access to programs' services.
- Connect all clients to the full range of services available in their communities.
- Ensure that job seekers have access to information and services that lead to positive employment outcomes.

Coordination

- One-Stop Operators (OSOs)
 - Hired by Workforce Development Boards
 - MUST coordinate the service delivery of required one-stop partners and service providers to ensure meaningful access to all programs through the one-stop delivery system.
 - o This MAY include:
 - Coordinating service providers within the Job Center and across the One-Stop Delivery System
 - Being the primary provider of services within the Job Center;
 - Providing some of the services within the Job Center;
 - Coordinating service delivery in a multi-center area, which may include affiliate job centers
- Coordinate Your Own Meetings
- Coordinate local educational opportunities
